a. FFA Camp: Curdy & Van Berkom

c. Agriculture Technology & Mechanical Systems CDE Committee: Kleven

Reported that Travis Fritel, Ben Krebs, and Pete Martin are working together to formulate a plan and will meet with Leon Schumacher, Ph.D. Professor Dept Chair, Ag and Biosystems Engineering who was hired in January 2022 and has extensive experience with the CDE at the National FFA Convention and in Missouri.

d. FFA Charter & Approved CTE Program: Kleven

Reported that CTE Administration has been made aware a couple of times regarding the motion made at the 11.19.21 meeting. There has been no response or action taken by CTE Administration regarding how this will affect CTE policy and other CTE programs. "Okke moved that to be a chartered ND FFA chapter a school must have an approved ND State Career and Technical Education Board agricultural education program. There will be a one-year probationary period for those who do not meet the criteria to be compliant. Leier second the motion. Motion Passed." The ND FFA Constitution and By-Laws will be updated at the State Convention, and this may enhance the discussion.

e. ND FFA Membership Policy: Fideldy-Doll

Fideldy-Doll reported on the proposed National FFA Membership that will go through the delegate process at National FFA Convention. The state Office will be proposing ND Constitution and By-Law changes throughout the delegate process at ND FFA State Convention.

New Business:

a. Winter Leadership Review: Fideldy-Doll/Kleven

New date change to September 17 & 18, 2022. All conferences will be under one roof at the Bismarck Event Center. Leier stated, Your Next Speaker, Inc. was a great change to for the 10-12 grade conferences.

b. State FFA Crop Show Review: Kleven

114 crop samples entered by three chapters. Carrington 48, Fessenden-Bowdon 64, Hope-Page 2. The event is on the threshold of not occurring according to ND FFA Policy. Kleven stated the state crop show event and committee is struggling because of several retirements of long-term leadership and nobody to fill the roles, plus very low participation.

c. State Winter CDEs Review: Fideldy-Doll/Kleven

A survey was sent out the morning of 3.22.22. The survey will be open for a few days. Board members reviewed the currently entered items. Substitution is wanted by some advisors. Some shared to allow the students to roam the entire line of agronomy pan classes and prevent them from getting off the rotations from pans to the other portions. Several comments were invalid because the people had not read/followed the State Handbooks for the CDEs.

Proficiency Judging sign-up link was sent out. Please encourage advisors to sign up. Next year utilize AET for district judging and advance the district winners.

e. State Horse Evaluation CDE: Fideldy-Doll/Kleven
